Subject: - Conduct of 2nd Round of Counselling / Submission of Online Preferences by the eligible candidates for admission to B.Sc. Nursing/B.Sc. Paramedical/B.Sc. Technology Courses-2026 for all candidates.

Pursuant to Notification No. 102-BOPEE of 2026 dated 10-07-2026 read with Notification No. 120-BOPEE of 2026 dated 24-07-2026 and the shortfall so received from various Government/Private Colleges/Institutions of UT of J&K/Ladakh due to non-joining/resignation etc through online JK BOPEE admission portal, it is hereby notified for information of all concerned candidates that the Board shall conduct the Second Round of Online (Upgradation/Allotment) counselling w.e.f. **03-08-2026 (2:00 p.m. onwards) to 05-08-2026 (Mid-night).**

The following candidates shall be eligible to participate in Second Round of Online (Preferences filling/Upgradation/Allotment) Counselling:

- i. Candidates who did not get any seat in the first round.
- ii. Candidates who did not get any seat in the 2nd round of counselling for horizontal candidates.
- iii. Candidates who have been allotted a seat during 1st or 2nd (Horizontal) round and have joined the Institution.
- iv. Candidates who have been allotted a seat during first round and have not joined the said seat. **They will not be eligible to participate for the said course in the said institution in this round. However, they will be eligible for admission in any course in other institutions/other courses in the same institution, subject to availability of seats.**
- v. Candidates who have been allotted a seat during 2nd round of counselling for horizontal candidates and have not joined the said seat. **They will not be eligible to participate for the said course in the said institution in this round. However, they will be eligible for admission in any course in other institutions/other courses in the same institution, subject to availability of seats.**
- vi. Candidates who have cancelled their admission by or before the last date of admission of the allotted seat of First Round at the Institution. **They will not be eligible to participate for the same course in the said institution in this round. However, they will be eligible for admission in all courses in other institutions/other courses in the same institution, subject to availability of seats.**

- vii. Candidates who have cancelled their admission by or before the last date of admission of the allotted seat of 2nd Round of counselling for horizontal candidates at the Institution. **They will not be eligible to participate for the same course in the said institution in this round. However, they will be eligible for admission in all courses in other institutions/other courses in the same institution, subject to availability of seats.**
- viii. The eligible candidates who have qualified the B.Sc. Nursing/B.Sc. Paramedical/B.Sc. Technology Common Entrance Test (CET)-2026 and have not participated during any of the previous rounds of counselling are also eligible for this round of counselling. They have to submit the **counseling fee of Rs. 1000/-** and then fill the preferences for this Round of Counselling.

Important Note:

1. **The process of online filling up of choices/preferences shall be available w.e.f. 03-08-2026 (2:00 p.m. onwards) to 05-08-2026 (Mid-night) and the instructions related to filling up of online Choices/Preferences shall be available on official website of the Board www.jkbopee.gov. in only.**
2. The candidates, who do not participate in the process of counselling by not filling up of the fresh preference forms, shall in no case be considered for allotment of seat **in this round**. They shall have no claim, whatsoever, on any seat filled up by the Board from amongst the candidates, who participate in the process.
3. The preferences indicated by the candidates during the 1st and 2nd (Horizontal) round of counselling shall be deemed to be cancelled and shall not be applicable for this round of counselling. The candidates have to submit fresh preferences for this round of counselling. If a candidate does not submit fresh choices/preferences during choice filling period, the candidate will not be considered for allotment of seat during this round and will retain the already joined seat, if any.
4. In this round, only vacant seats shall be filled from respective categories as from where shortfall has been received i.e. **the seats left-out by the OM candidates during the 1st and 2nd (Horizontal) round shall be allotted to the OM candidates and those left by the category candidates shall be allotted to the category candidates on the basis of merit-cum-preferences.** The seats vacated by the candidate upon upgradation in this round shall be filled up simultaneously.
5. The Horizontal category seats which remained vacant after 2nd round of counselling for Horizontal Category Candidates have been de-reserved and shall be filled up from all candidates of their respective main categories in this round of counselling as mentioned by the Board vide Notification No. 116-BOPEE of 2026 dated 21-07-2026.
6. The candidates who have paid the online counselling fee during the 1st or 2nd (Horizontal) Round shall not be required to pay any fee during this round of counselling.

7. Candidates must consider available seats thoroughly and opt for such seats for which they are interested because Seat once allotted cannot be changed.
8. Seat matrix shall be uploaded separately and all the participating/eligible candidates are advised to go through seat matrix before participating in the counselling process.

The other terms and conditions shall remain the same as notified by the Board in the e-Information Brochure and Notifications/Notices issued from time to time in this regard.
